There will be a dance for competing groups on the night of their performance and each member of the two groups concerned will receive 2 complimentary tickets. Groups will be responsible for providing their own meals before and after the shows and for hotel accommodation. Facilities to purchase light snacks will be available at the dances.

Groups are not permitted to rehearse in the theatre prior to the official rehearsal on the day of their performance.
